## **READ YOUR OPERATOR'S HANDBOOK CAREFULLY BEFORE MOUNTING AND USING YOUR TANK. KEEP YOUR HANDBOOK IN A SAFE PLACE.**

### Introduction

---

Congratulations on your purchase of a Rapid Spray Modular Cartage Tank. Ideally suited to water cartage for contractors, farmers, earthmovers, landscapers, potable water carriers and many other applications.

#### **Warnings**

- ! 1. When mounting to any vehicle ensure that you have read the Vehicle Owner's Manual and that you comply with all the weight restrictions as specified by the vehicle manufacturer, as overloading can cause injury or death.
- ! 2. To ensure your own safety and that of your employees if applicable you must comply with all relevant environmental, work place health and safety legislation and codes of practice.
- ! 3. Ensure tank is firmly secured in an appropriate manner. Where applicable tank mounting may need to be designed / approved by an engineer.
- ! 4. Care should be taken at all times, particularly when operating on rough or steep terrain. Drivers should be aware of water surge at all times.
- ! 5. OH&S requirements for working at heights must be complied with as applicable.
- ! 6. Personal Protection Equipment must be worn if required.
- ! 7. Improper or careless use of this tank can cause serious injury or death. Minors should never be allowed to use this tank.
- ! 8. Tank is a confined space. Ensure compliance with OH&S requirements if entering tank.
- ! 9. You must be in good mental health to operate this tank and not be under the influence of alcohol or any drugs that could impair your vision, physical strength, dexterity, judgement, or other mental capacity.



RAPID SPRAY provides a quality tank and water cartage/spray system for the use of our clients.

To ensure continuous and quality use, we undertake this Warranty Agreement to enable trouble free and Quality Assured service of our tanks and spray systems.

Please read and understand all documents in the Warranty Pack adhered to your tank.

This pack contains:

1. Operators Handbook
2. Warranty Registration Form (with Serial #)
3. Mounting Plan and Directions
4. Frame Drawings
5. Documents to be Returned (including Pre-paid envelope)
6. Quality Assurance checklist
7. Load Restraint Guide (National Transport Association)

On purchasing a Rapid Spray tank or system, customers are requested to read all documents carefully and **ensure they understand** the operation system, ensure correct mounting and restraint to the specifications and drawings provided, **prior to use**.

Step 1. Take ALL documents and plans from plastic sleeve and read them

Step 2. Complete Warranty Registration Form and return to **Rapid Spray, PO BOX 3119 SINGLETON NSW 2330** (attach copy of receipt to Warranty Form) to initiate registration,

Step 3. Purchase or manufacture frame/mounting system in conjunction with Rapid Spray's design/plan

Step 4. Mount and secure tank in compliance with specifications as supplied by RAPID SPRAY

Step 5. Ensure any fittings from tank to motor/sprays or outlets are flexible and NOT rigid

In all cases WARRANTY WILL Include:

- Workmanship of tank (manufacture)
- Quality of raw materials and fittings
- Integrity and workmanship of frame/skid – if purchased from Rapid Spray
- Guarantee on NEW Tank for a pro-rata period of 5 years (for original purchaser)
- Mounting instructions are adhered to and proof of purchase is provided

**TO AVOID DOUBT – Warranty does not cover the following:**

- Tank mishandling, misuse, or faults caused by failure to follow mounting advice or routine maintenance.
- Unauthorised alterations or changes to tanks (including welding, cutting, or mounting)
- Damage from use of rigid/fixed outlets to pumps or other fittings
- Damage from wear or tear
- Incorrect placing and securing of pumps or tanks
- Freight or costs associated with repairs associated with any of the above
- Costs associated with dismantling, installation or re-installation of the tank or frame

- You will be notified if your product needs to be returned and/or the action to be undertaken.
- Our aim is to have your unit returned As Soon As Possible, depending on the seriousness of your problem
- Remember, it is at the discretion of Rapid Spray to repair, replace or refund the unit,
- If any unit (pump, motor or tank) is found to have been mishandled, inappropriately used, mounted or secured; the costs associated will be incurred by the client.

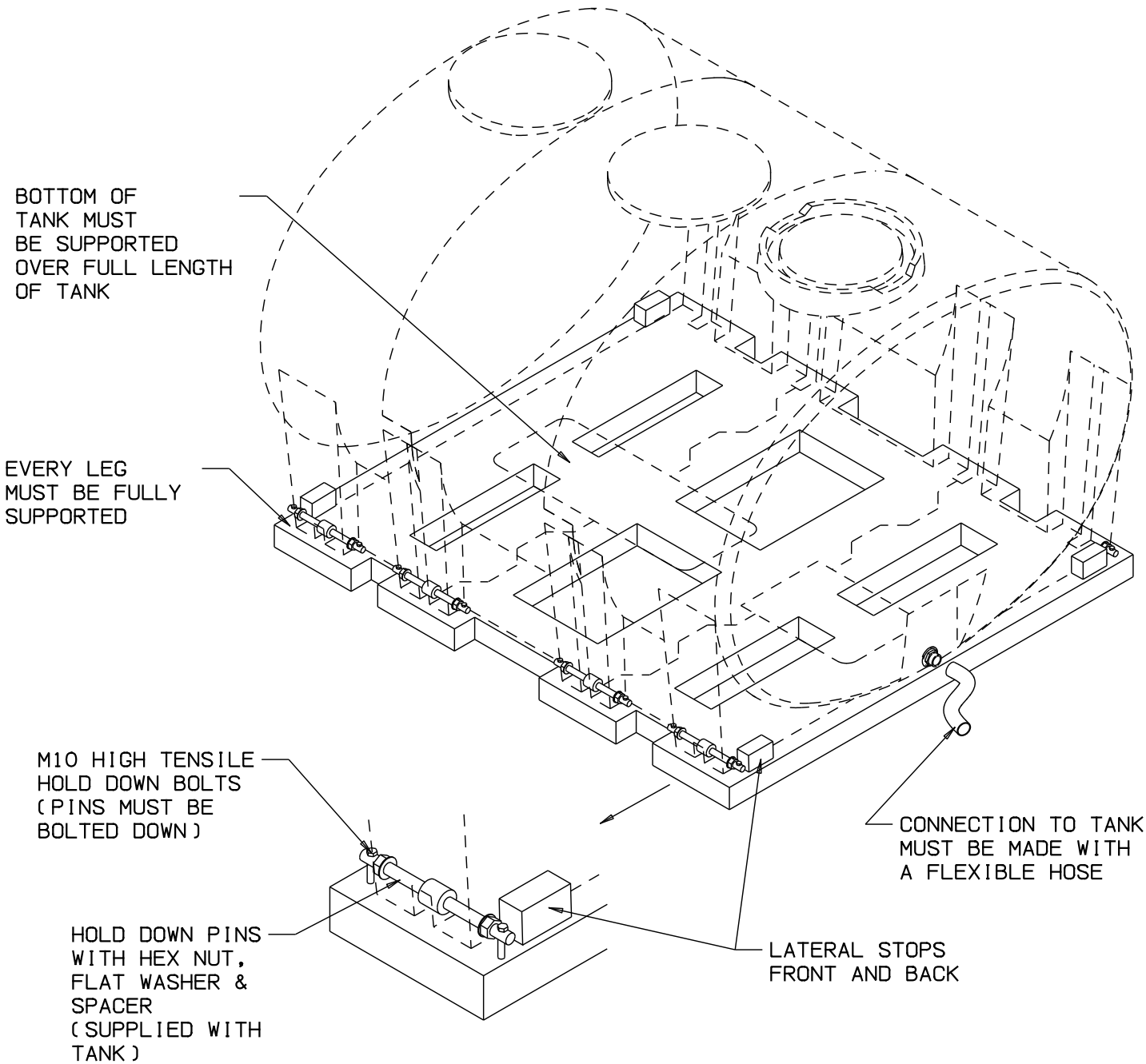

<b>Task</b>	<b>Hazards</b>	<b>Risk</b>	<b>Control Measures</b>
1. Ensure tank mounted correctly on vehicle-do not overload vehicle. <u>(Testing-partially fill the tanks with water &amp; test the tanks and/or pumping system, if necessary, before use. If tanks are not joined, each tank will have to be tested individually.)</u>	Load is not secured; overloading the vehicle; manual handling; slips, trips or falls; fingers jammed; overhead powerlines-electricity; leaks; tank is a confined space, if entered.	Med	Read/follow decals on tank; follow safe manual handling techniques:-don't lift on your own if > 20kg, bend knees & keep back straight; keep fingers clear; keep tanks at least 8m away from overhead powerlines; keep water away from electrical sources; make sure tanks mounted securely-mounting to comply with codes of practice and transport authority requirements; don't exceed vehicle load limit; follow state legislation & AS 2865: 2001 Confined Space; chassis mount frame to be designed by licensed Truck Body Engineer.
2. Check weather and ground conditions for stability.	Manual handling; ground instability.	Low	Follow safe manual handling techniques as above; drive cautiously to suit ground and weather conditions.
3. Fill tanks with water or chemicals using a pump, hydrant, hose or similar apparatus.	Manual handling; slips, trips or falls; ground instability; weather conditions; falling from height; use of chemicals.	Med	As above 1 & 2. Ensure fall prevention strategy exists if on the tank, whilst on the back of a vehicle filling the tank-work platform or hand rails in place &/ or the person filling the tank is secured with a safety line or harness fall arrest system in place; follow the MSDS for chemical use.
4. Check that transport vehicle is safe before use, i.e. where applicable:- wheel nuts, tyre pressure and condition, bearings, tow hitch, has been serviced, etc. Driving and using the tanks from a vehicle-take into account the sway of the contents in the tank when driving.	As above; loss of load; work in heat & cold; noise; exceed load limit of vehicle; strap breakage; hose entanglement; exhaust fumes; terrain & slopes; Tank contents.	High	As above 1 & 2; wear clothes to suit heat & cold; wear hearing protection if pump noise > 85 dBA; follow the manufacturer's safe operation instructions for the vehicle and the pump/spray unit; don't overload-water weighs 1kg per 1 litre; secure load; keep hose attachments tidy; fully baffled tank units improve the stability of the transport function.
5. Clean up, maintenance & storage.	As above for 1-4 where applicable.	Low	As above; store tank in a dry, well ventilated area.
