Rapid Spray Policy: Minors

Any products sold by Rapid Spray and it's distributors are not suitable for use by children (aged 0 - 18yrs) or with children (0 - 18yrs) near.

Improper or careless use of equipment can cause serious injury or death.

#### **TANKS**

All children (aged 0 – 18yrs) should be kept away from Rapid Spray manufactured and imported tanks.

## DO NOT ALLOW CHILDREN OR PUT CHILDREN INTO RAPID SPRAY TANK(S).

WARNING: leaving children unattended nearby any Tank containing liquid could result in drowning. Leaving children unattended with Tank could cause serious injury or death.

WARNING: leaving children unattended with any empty Tank could cause a suffocation accident due to confined spaces. Leaving children unattended with Tank could cause serious injury or death.

WARNING: Do not use Rapid Spray tanks as recreational swimming tanks. Drowning could occur.

As outlined in the Buddy Smart Reel Operators Handbook:

"Improper or careless use of this tank can cause serious injury or death. Minors or persons under the influence of alcohol or drugs should never be allowed to use this tank."

#### **SPRAYERS**

## **BUDDY SMART REEL**
